

**End User License Agreement for
*The Complete National Geographic***

This End User License Agreement (this “**Agreement**”) is between you as the end user (“**You**” or “**Your**”) and National Geographic Society (“**NGS**”).

IT IS IMPORTANT THAT YOU CAREFULLY READ AND UNDERSTAND THIS AGREEMENT. TAKING ANY STEP TO SET-UP OR INSTALL THE SOFTWARE (AS HEREINAFTER DEFINED) CONSTITUTES YOUR ASSENT TO AND ACCEPTANCE OF THE TERMS AND CONDITIONS OF THIS AGREEMENT. YOUR WRITTEN OR ELECTRONIC APPROVAL IS NOT A PREREQUISITE TO THE VALIDITY OR ENFORCEABILITY OF THIS AGREEMENT. IF YOU DO NOT AGREE WITH ALL TERMS OF THIS AGREEMENT, YOU MUST IMMEDIATELY RETURN THE SOFTWARE AND DOCUMENTATION (AS HEREINAFTER DEFINED) WITH THE ORIGINAL PACKAGING AND PROOF OF PAYMENT TO THE PLACE OF PURCHASE.

1. Definitions.

1.1 “Documentation” shall mean the user guides and manuals for installation and use of the Software that NGS makes generally available.

1.2 “Software” shall mean the interactive entertainment software product identified above, in object code form only, the files that contain editorial content of the magazine, and the media, Documentation and any updates provided by NGS to You and for which You are granted a license pursuant to this Agreement.

2. Grant of License; Ownership. NGS grants You a limited, non-exclusive, nontransferable, royalty-free license to use one copy of the object code form of the Software for personal, non-commercial and lawful use on a single computer. NGS does not transfer title to the Software to You; this license shall not be considered a “sale” of the Software. You agree that the Software belongs to NGS, including all intellectual and proprietary rights, unless otherwise specified. NGS retains all right, title and interest in and to the Software at all times, and regardless of the form or media in or on which the original or other copies may subsequently exist. Any suggestions, ideas or inventions that You voluntarily and optionally disclose to us through any means will be used, or not used, by NGS at NGS’ sole discretion; and, NGS will have no obligation to You regarding any ideas or inventions that You disclose through such means. All other rights are reserved to NGS except as expressly provided herein.

3. Restrictions. You may not (and You agree not to permit another person to): (i) rent, lease, sell, sublicense, assign, or otherwise transfer or copy the Software, except as expressly permitted by this Agreement; (ii) reverse engineer, decompile, disassemble or otherwise reduce the Software to a human-readable form, except to the extent that this restriction is expressly prohibited by applicable law; (iii) modify, translate or create derivative works based on or using the Software or any component thereof; (iv) remove any copyright or other proprietary notices contained in or relating to the Software and/or any of its components; (v) create any other software that incorporates the Software; or (vi) reproduce, republish or reuse

any photograph or any other element or content of the Software, individually or in combination, but applicable copyright law may give you such rights. If you are uncertain about your rights, please contact an attorney. WITHOUT LIMITING THE FOREGOING, COPYING THE SOFTWARE AND/OR ANY COMPONENT THEREOF TO ANY OTHER SERVER OR LOCATION FOR FURTHER REPRODUCTION OR REDISTRIBUTION IS EXPRESSLY PROHIBITED. No right, title or interest in or to any trademark, service mark, logo or trade name of NGS or its licensors, suppliers or affiliates is granted under this Agreement.

- 4. Geobrowse Functionality.** The Geobrowse function relies on content and/or services provided by Microsoft Corporation and accessed by You over the internet. The functionality is only available to You through an internet connection. Such content and/or services are governed by separate Terms of Use <http://go.microsoft.com/fwlink/?LinkId=21969> and a separate Privacy Policy <http://go.microsoft.com/fwlink/?LinkId=21970>, to which you must agree in order to use the Geobrowse function. NGS may terminate this Agreement at any time in the event of a material breach by You of the terms of this Agreement.
- 6. Maintenance.** NGS is not obligated to provide maintenance and technical support to You for the Software.
- 7. Upgrades.** You acknowledge that NGS may issue upgraded versions of the Software from time to time. Your license to an existing version of the Software may, at NGS' discretion, expire when new versions of the Software are released. Notwithstanding the foregoing, NGS has no obligation to make available to You any subsequent versions of the Software. The Software will operate only on those hardware and software platforms specified in the Documentation. It is Your responsibility to ensure that You have the appropriate software and hardware (and, if applicable, Internet connection) to operate the then-current version of the Software. NGS reserves the right to cease supporting any hardware or software platform at any time, with or without notice. NGS may modify the Software at any time without notice.
- 8. Disclaimers of Warranty.** TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, NGS AND ITS LICENSORS AND SUPPLIERS PROVIDE THE SOFTWARE "AS IS" AND WITH ALL FAULTS, AND HEREBY DISCLAIM ALL WARRANTIES AND CONDITIONS, EITHER EXPRESS, IMPLIED OR STATUTORY, INCLUDING, BUT NOT LIMITED TO, ANY IMPLIED WARRANTIES OR CONDITIONS OF MERCHANTABILITY, OF FITNESS FOR A PARTICULAR

Limitation of Liability and Remedies.** NOTWITHSTANDING ANY DAMAGES THAT YOU MIGHT INCUR FOR ANY REASON WHATSOEVER (INCLUDING, WITHOUT LIMITATION, ALL DAMAGES REFERENCED ABOVE AND ALL DIRECT OR GENERAL DAMAGES), THE ENTIRE LIABILITY OF NGS AND ANY OF ITS LICENSORS, SUPPLIERS AND AFFILIATES UNDER ANY PROVISION OF THIS AGREEMENT AND YOUR EXCLUSIVE REMEDY FOR ALL OF THE FOREGOING SHALL BE LIMITED TO THE AMOUNT ACTUALLY PAID BY YOU FOR THE SOFTWARE. THE FOREGOING LIMITATIONS, EXCLUSIONS AND DISCLAIMERS SHALL APPLY TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, EVEN IF ANY REMEDY FAILS ITS ESSENTIAL PURPOSE.
- 11. Export Administration.** You will comply fully with all relevant export laws and regulations of the United States, including, without limitation, the U.S. Export Administration Regulations (collectively “**Export Controls**”). Without limiting the generality of the foregoing, You will not, and You will require Your representatives not to, export, direct or transfer the Software, or any direct product thereof, to any destination, person or entity restricted or prohibited by the Export Controls.

U.S. Government Rights.** If You are, or are entering into this Agreement on behalf of, any agency or instrumentality of the United States Government, the Software is “commercial computer software” and “commercial computer software documentation,” and pursuant to FAR 12.212 or DFARS 227.7202, and their successors, as applicable, use, reproduction, and disclosure of the Software are governed by the terms of this Agreement.

You agree that after receipt of any revised version of this Agreement, You will be deemed to have accepted this revised version unless and until NGS receives written notice from You informing NGS that You do not accept the revised version of the Software and that You have removed the Software from Your computer. Failure to remove and destroy the Software from Your computer will be deemed an acceptance of the revised version of this Agreement. Except as provided in this section, this Agreement may not be revised except in writing signed by all relevant parties.
- 15. Trademarks.** “National Geographic” and the Yellow Border Design are trademarks of National Geographic Society.
- 16. Miscellaneous.** This Agreement is governed by and construed in accordance with the laws of the State of New York, United States of America, without regard to its principles of conflicts of law. You agree to submit to the exclusive jurisdiction of any State or Federal court located in the New York, New York, and waive any jurisdictional, venue or inconvenient forum objections to such courts. If any provision of this Agreement is found to be unlawful, void or for any reason unenforceable, then that provision shall be deemed severable from this Agreement and shall not affect the validity and enforceability of any remaining provisions. This is the entire Agreement between us relating to the subject matter herein and supersedes any and all prior or contemporaneous written or oral agreements between us with respect to such subject matter. This Agreement is not assignable, transferable or sublicenseable by You except with NGS’ prior written consent. No waiver by either party of any breach or default hereunder shall be deemed to be a waiver of any preceding or subsequent breach or default. Any heading, caption or section title contained in this Agreement is inserted only as a matter of convenience and in no way defines or explains any section or provision hereof.
